- Order of the Minister of National Education no. 3236/10.02.2017 Methodology for admission to studies and schooling of foreign citizens on budgeted places and with a scholarship and on budgeted places but without a scholarship in accredited state higher education institutions, and
- Letter of the Ministry of Education 1154/09.06.2022 paragraph 2) regarding the granting of budgeted study places, but with a scholarship, to citizens of third countries, who do not fall into the category of Romanians everywhere and/or have dual citizenship (Romanian and another state) upon the proposal of higher education institutions, in the academic year 2022 – 2023

CHAPTER I. GENERAL PROVISIONS

Art. 1.

Each accredited state higher education institution, which educates foreign students (with the exception of Romanians everywhere, Romanian citizens residing abroad), and citizens who have dual citizenship (Romanian and another state), enrolled on non-budgeted places in a foreign currency (in accordance with the provisions of Government Decision no. 22/2009, approved with amendments by Law no. 1/2010), with outstanding academic and scientific results, will submit to the Ministry of Education – Directorate General for International Relations and European Affairs:

- (1) the official letter, signed by the rector of the educational institution, by which the persons proposed for receiving a budgeted study place and with a scholarship are nominated;
- (2) maximum 5 application files;
- (3) table containing the list of selected candidates.

Art. 2.

The application file will contain:

- a) list with all documents attached to the file;
- b) GDPR, the written consent of the candidate for the dissemination of the name in the public space.
- c) standard application for registration in the competition to obtain a scholarship from the Ministry of Education (Annex I)
- d) academic record for each year of university study (except for the preparatory year);
- e) copy of the bachelor's degree and diploma supplement (transcript), or certificate showing the academic record for all years of study, as well as the grades obtained in the bachelor's degree examination (for graduates of the current year) for candidates requesting to continue with specialisation and doctoral studies, and certified translation in Romanian, English, French;
- f) copy of the master's degree diploma and diploma supplement for candidates requesting to continue with doctoral studies, and certified translation in Romanian, English, French;
- g) certificate with the average grade obtained at the doctoral studies admission examination - for candidates for doctoral university studies;
- h) notarised copy of the birth certificate;
- i) copy of the passport;
- j) copy of the residence permit in Romania;

k) notarised affidavit that the information provided is accurate and complete (Annex II).

Art. 3. The documents in Section 2, Article 13 must be submitted to the Vice-Rector's Office for International Relations between 1 September and 16 September 2022. After this date, neither new files nor additions to the file will be accepted.

Art. 4.

The application procedure is as follows:

- a) The Senates of accredited higher education institutions will establish the criteria based on which application proposals are formulated and the procedures for applying the legal provisions, and will inform potential candidates by posting them on the official website of each higher education institution.
- b) The nominal list of application proposals will be approved by the Senate of the accredited higher education institution, and will be posted on the official website.
- c) The nominal list and candidate files will be submitted to the Ministry of Education – Directorate General for International Relations and European Affairs until 1 October 2022.

Art. 5.

The following categories of students may apply to obtain these scholarships:

- a) foreign citizens, enrolled on non-budgeted places in foreign currency, who have completed at least one year of studies, apart from the preparatory year, in the full-time form of education, in an accredited state higher education institution, and who have obtained at least the average grade of 9.00
- b) foreign citizens, graduates of a university study program in Romania, in the full-time form of education, who have obtained a general average grade of at least 9.00 in the bachelor's degree examination, and who continue their studies in our university as physicians registered for specialisation, with payment of the fee in foreign currency
- c) foreign citizens, graduates of a university study program in Romania, in the full-time form of education, who have obtained a general average grade of at least 9.00 in the bachelor's degree examination, and who continue their doctoral studies in our university, with payment of the fee in foreign currency

Art. 6.

Scholarships are awarded considering the following tiebreaking criteria, within the limit of the number of grants available.

a. For the bachelor's degree program:

1. The main selection criterion is the **AVERAGE GRADE** for the previous academic year (2021 – 2022). **The minimum average grade accepted is 9 (nine).**
2. If two candidates opting for the same place have the same annual average grade, a first tiebreaking criterion will be applied: the average grade of the first semester, academic year 2021 - 2022.
3. If the candidates are equal even after considering the semester average grade, a second tiebreaking criterion will be applied: the average grade of the second semester, academic year 2021 - 2022.

b. For the specialisation university study program:

1. The main selection criterion is the **AVERAGE GRADE** obtained in the bachelor's degree examination. **The minimum average grade accepted is 9 (nine).**
2. If two candidates opting for the same place have the same average grade obtained in the bachelor's degree examination, a first tiebreaking criterion will be applied: the average grade obtained during bachelor's degree studies in the specialty where the candidate is enrolled
3. If the candidates are equal even after considering the first two criteria, a second tiebreaking criterion will be applied: the average grade of the years of study during the bachelor's degree studies.

c. For the doctoral university study program:

1. The main selection criterion is the **AVERAGE GRADE** obtained in the bachelor's degree examination. **The minimum average grade accepted is 9 (nine).**
2. If two candidates opting for the same place have the same average grade obtained in the bachelor's degree examination, a first tiebreaking criterion will be applied: the average grade obtained in the doctoral studies admission examination
3. If the candidates are equal even after considering the first two criteria, a second tiebreaking criterion will be applied: the average grade of the years of study during the bachelor's degree studies.

Art. 7.

Candidates thus selected become beneficiaries of grants by order of the Minister of Education. The final results of the selection will be communicated to the higher education institutions, and published on the official website of the Ministry of Education.

Art. 8.

In accordance with the requirements of the Ministry of Education, the university may submit a maximum of 5 (five) application files. The 5 available places are distributed as follows:

- 1 place for the Faculty of Medicine
- 1 place for the Faculty of Dental Medicine
- 1 place for the Faculty of Pharmacy
- 1 place for physicians undergoing specialisation
- 1 place for doctoral studies

Art. 9.

Any change in the status of the scholar student or in his/her study program (university, field, subfield of study, extension of the doctorate, etc.) will be made with the approval of the Ministry of Education.

CHAPTER II. FINAL PROVISIONS

Art. 10. The Senate of the "Victor Babeș" University of Medicine and Pharmacy of Timișoara approved this Methodology in the meeting dated 29.06.2022, the date on which it enters into force.
