Art. 1 General considerations

- (1) The bachelor thesis is an important component of the evaluation of the knowledge and scientific activity of the graduates of all study programmes of the "Victor Babes" University of Medicine and Pharmacy of Timișoara (VBUMPhT).
- (2) The bachelor thesis tests the ability to design and conduct independent research, as well as to write and present the results of research according to the rules of the academic community.

Art. 2 Topics and coordinators

- (1) The major criterion in the choice of the field/topic of the bachelor thesis must be the advantage the research to be carried out can offer in the training process of the future specialist. The topic under consideration should be related to the graduate's programme of study/specialisation, to that area of activity in which the graduate has both sound general knowledge and a particular interest.
- (2) Teaching staff are obliged to accept to coordinate undergraduate work. A scientific coordinator may supervise up to a maximum of 8 undergraduate theses per year. There must be free communication between the student and the scientific coordinator, appropriate to the academic environment, based on mutual respect and appreciation.
- (3) The scientific coordinators of the undergraduate works may be teachers of the faculty, from the rank of university assistant to the rank of university professor or/and teachers or researchers from other universities or institutions that have agreements in this respect with VBUMPhT. Academic assistants employed on a fixed-term basis may only coordinate undergraduate work together with a full professor.
- (4) The topics of the undergraduate thesis are determined in accordance with the research priorities of the disciplines, and in agreement with the scientific coordinators.
- (5) Students are obliged to inform the Dean of the Faculty of the title of the bachelor thesis and the agreement of the scientific coordinator (Annex 1) by 1 June of the penultimate year of study at the latest.
- (6) The student may change the subject and/or the scientific coordinator only once, after informing and with the consent of the original scientific coordinator and with the consent of the Dean of the Faculty. Changing the title and the scientific coordinator is not possible from the 2nd semester of the last year of study.

Art. 3 The structure of the Bachelor thesis

- (1) The bachelor thesis must have the following structure:
 - A) Cover page
 - B) Title page
 - C) Contents
 - D) List of abbreviations and symbols/Glossary of terms
 - E) Layout of the thesis:
 - a) Introduction
 - b) Contents
 - c) Conclusions and personal contributions
 - d) Bibliography
 - e) Appendices (optional)

- (2) The cover of the thesis must include the following information: full name and logo of the university, faculty, department and discipline, author of the thesis, scientific supervisor(s), and year of the thesis. It is laminated in colourless plastic.
- (3) The title page repeats the information given on the cover and in addition has the title of the thesis.
- (4) The table of contents of the thesis will contain information on the whole thesis, i.e.: introduction, contents, conclusions, bibliography, and appendices (optional), and will include the titles of all chapters and sub-chapters accompanied by the page number at which each chapter and sub-chapter begins.
- (5) The list of abbreviations and symbols as well as the notations frequently used in the dissertation must comply with the standards used in the literature. Symbols, abbreviations and frequently used notations must be written in alphabetical order, starting with the Latin alphabet, lower case then the corresponding capital letters, and continuing with the Greek alphabet, lower case then the corresponding capital letters.
- (6) The license thesis itself includes:

a) The introduction

The introduction to the thesis is numbered in Roman figures and is intended to place the research in a temporal, historical, geographical and professional context and covers 1-2 pages.

The introduction must contain:

- i) the motivation for the choice of the research topic
- ii) the importance and actuality of the topic
- iii) the subject's place in international, national, and regional concerns
- iv) the scientific objectives to be addressed in the scientific research
- v) brief comments on the research method and methodology

b) The content

The content of the paper must distinguish two components: the theoretical or conceptual component and the practical or applied component (which contains one or more applications that meet the objectives of the paper). While the theoretical component demonstrates the author's knowledge, the practical component requires the identification/formulation of solutions with applicability to the problem addressed in the paper.

The content of the thesis must present a balance between the two components, with an emphasis on the application side, and thus demonstrate the graduate's ability to creatively apply his/her theoretical knowledge. It is recommended that the theoretical part should not exceed 30-35% and the practical part approximately 65-70%.

The content of the dissertation is numbered with Arabic numerals and must be structured in three main parts:

- a) General part
- b) Special part
- c) Conclusions and own contributions
- d) Bibliography
- e) Appendices (optional)

a) **The general part** presents the current state of knowledge on the topic under investigation – a descriptive analysis of achievements in the field, based on primary documentation.

b) **The special part** contains the candidate's contributions and presents the type of approach to the research topic, i.e. exploratory research or applied research, occupying the major part of the thesis. The special part of the dissertation may be in the form of a *primary study* (original observational, experimental, or interventional research) or of a *secondary study* (a summary of primary studies in the literature in the form of a *systematic review or meta-analysis*).

In the case of a *primary study*, the Special part comprises an experimental part and a part devoted to the research results. The experimental part presents the material studied and *the research methods/techniques* used, depending on the nature of the thesis and the research carried out. The part devoted to the research results may contain one or more chapters depending on the method chosen for the experimental verification, presenting, where appropriate, descriptive tables, graphs, and illustrations, as well as a discussion of the methods used in comparison with those used in the field at national and international level.

In the case of a *secondary study*, the Special part will be written in the form of a review article, meta-analysis, comparative analysis or critical analysis of literature data (without limitation of qualification for this type of study). The secondary study is an option for emergencies, alerts, situations where teaching is carried out *online* or other special situations as determined by the VBUMPhT Board of Directors.

c) **The conclusions and own contributions** should highlight:

- the extent to which the objectives of the scientific research have been achieved
- own contributions
- the directions in which the research should be continued

This part of the dissertation is a separate chapter and will be presented briefly on a maximum of 1-2 pages, with a concrete, punctual character.

d) **The bibliography** contains a list of all the sources of information directly consulted and used by the graduate for the writing of the thesis, with the following mentions:

- the bibliographical references must be selected and written in a number strictly necessary for the documentation of the thesis, without being exhaustive. The bibliographical list, written in Vancouver style, must contain in the text the indexes of representative works in the following categories: books, articles in specialized journals, doctoral theses, and university courses, published in print or in electronic format, including web pages (most bibliographical titles must be dated within the last 10 years).
- a bibliographic index may be cited more than once in a work
- the bibliographic index is inserted in the text immediately after the statement of information and before the full stop
- bibliographic titles will be numbered and presented in the order of the first mention in the text
- recommendations for writing bibliographic references should follow the Vancouver model <http://www.library.uq.edu.au/training/citation/vancouv.pdf>;
- up to 3 authors cite all authors, over 3 authors cite "et al" after the first three authors
- journal titles may be abbreviated according to the recommendations of Journals Indexed for MEDLINE- www.ncbi.nlm.nih.gov/nlmcatalog/journals
- in the case of books, specify the chapter with the corresponding pages.



Examples:

Journal article: Fried LP, Kronmal RA, Newman AB, et al. Risk factors for 5-year mortality in older adults: the Cardiovascular Health Study. *JAMA*. 1998;279:585–592.

Book: Evans JG, Franklin Williams T, Lynn Beattie B: Oxford Textbook of Geriatric Medicine, 2nd Edition. Oxford University Press, 2000

e) Annexes may have one or more pages, which will be numbered in ascending Roman numerals (Annex 1, Annex 2, etc.). Each annex should be mentioned at least once in the text of the paper.

Art. 4. Rules for writing the bachelor thesis

- (1) The cover of the thesis will be white and the lettering black (Annex 2).
- (2) Use the diacritics specific to the language in which the thesis is written (ă, î, â, ș, ț for Romanian).
- (3) Text within normal paragraphs should be aligned between the left and right margins (*justified*).
- (4) Page numbering starts from the title page to the last page of the paper, but the page number appears starting from the "Contents"; the page number is inserted in the footer (centered or right).
- (5) The chapters of the General part and of the Special part, respectively, always begin on a new page.
- (6) Printing will be on one side only.
- (7) Formatting the A4 page for printing:
Margins: Top 2.5cm, Bottom 2.0cm; Right 2.0cm, Left 3.5cm.
Colons: Top 1.2cm, Outside.
- (8) The typesetter will use the following types, of typefaces:
 - i. Main typeface for the thesis text - **TIMES NEW ROMAN 12**.
 - ii. Body of the thesis written at 1 ½ lines.
 - iii. Cover text: Annex 2A
 - iv. Figure legends and tables will be written in **TIMES NEW ROMAN 10**
Spacing between the lines will be 1.
- (9) The bibliography shall be written with **TIMES NEW ROMAN 11**
The wording should be 1 line.
- (10) The first pages and the Introduction shall be numbered with Roman numerals as follows:

Page	I	Title page (not numbered)
	II - III	Contents
	IV (or III)	List of abbreviations and symbols
	V (or IV)	Dedication (optional)
	VI (or V)	Acknowledgements
	IVII-VIII (VI-VII)	Introduction
- (11) The body of the thesis written with **TIMES NEW ROMAN 12** should be between 30-60 pages (without bibliography).
- (12) The appendix of the thesis should be numbered in roman letters. It must contain copies of your own submitted/published papers (if applicable). It may optionally contain figures and tables.
- (13) The template of the thesis is provided in Annex 2B.

Art 5. Completion and public presentation of the thesis.

- (1) The thesis must comply with the writing standards set out in this Methodology.
- (2) The thesis should be written in an impersonal style (NOT in the first person) and the information should be communicated in a direct and understandable manner, in a logical and coherent structure.
- (3) The thesis may be written and defended in Romanian, English or French (depending on the programme of study).
- (4) Completion of the thesis is subject to the approval of the scientific coordinator (Annex 6) and will be submitted to the Dean of the Faculty according to the established timetable.
- (5) The thesis can only be defended if it is accompanied by the originality statement (Annex 3), the abstract (Annex 4), and the thesis report (Annex 5) signed by the scientific coordinator(s).
- (6) The presentation of the thesis/diploma/dissertation in front of the examination committee is at least as important as its writing. The final mark obtained by the graduate represents both the result of the evaluation of the thesis by the coordinating professor (evaluation recorded in a signed original report) and the result of the evaluation of the committee, following the presentation of the thesis by the graduate.

Art 6. Anti-plagiarism checking of undergraduate thesis

- (1) The undergraduate papers, to be checked with the anti-plagiarism software used by the University, will be sent by e-mail in *Word format without a bibliography* by the deadline set according to the Undergraduate Examination Calendar, before the end of the registration deadline for the examination, for all study programmes in the Faculties of Medicine, Dental Medicine and Pharmacy to the following addresses:

- (2) The papers will be checked in their complete, final form **no more than twice**.
 - **The name of the candidate** for the licensing examination should be mentioned in the subject of the e-mail.
 - In order to avoid overcrowding in the last days, the license papers will be sent in due course, respecting the deadlines set out in this methodology.
- (3) **The similarity report** generated after the first check and **the full similarity report** generated after the second check (if applicable) (.pdf and .html) contain all the data necessary to establish the originality of the work by the coordinator of the thesis, who is the only one in a position to carry out an accurate analysis of the loans detected by the Anti-Plagiarism system.
- (4) The Similarity Report must always be analysed by the coordinator of the thesis. Consideration should also be given to whether too many potential loans from a single source appear.

(5) The value of Similarity Ratio 1 determines what percentage of the paper contains sentences of 5 words or longer found in the parent database, other affiliated universities or Internet sources. The Coefficient of Similarity 1 should normally not exceed 50%.

(6) The value of the Similarity Coefficient 2 determines what percentage of the document contains sentences of 25 words or longer found in the above databases. The Coefficient of Similarity 2 should not normally exceed 5%.

(7) In order to make an accurate interpretation of the Similarity Report, **the following** must be done:

(a) it is necessary to check the value of the Similarity Coefficients and it is considered suspicious to exceed the threshold of 50% for Similarity Coefficient 1 and 5% for Similarity Coefficient 2;

b) it is necessary to analyse the list of "Longest fragments identified as similar" (fragments with a number of words greater than 200 are considered suspicious, and therefore require careful verification; if such fragments exist, they must be found, using the "mark fragment" link, and it must be verified whether these fragments are quoted);

c) scroll down the list of "Documents containing similar fragments", especially considering documents containing fragments exceeding the limit of Similarity Quotient 2 (these are marked with bold letters). If such documents appear, especially if they are at the beginning of the list, the "mark fragment" link should be used and it should be checked whether they are short sentences scattered throughout the document (in this case we can consider them as random borrowings), or they are long fragments of text which are contiguous and separated only by short sentences (this kind of situation will raise suspicions);

d) if any kind of suspicion arises, the Similarity Report must be subjected to an exact analysis, which is based, in addition to using the functions of the Similarity Report presented in points 1-3, on the exact analysis of the document content, taking into account the marking of fragments, which have been discovered by the system in other texts."

(8) If the coordinator of the thesis finds that these thresholds are exceeded in the Similarity Report, the candidate will be required to redo the parts identified with problems under the supervision of the coordinator. The paper will then be resubmitted to generate the Full Similarity Report. If problems are found to persist, the paper and the related reports will be sent to the Director of the Anti-Plagiarism Programme of The "Victor Babeș" University of Medicine and Pharmacy Timișoara at **sursoniu@umft.ro**.

(9) The (Complete) Similarity Report generated after the anti-plagiarism check will be signed by the coordinator/s of the thesis.

(10) The document obtained from the verification of the originality of the content of the work with the help of the anti-plagiarism program of the university, signed and registered, shall be submitted by the students to the Dean's Office of the Faculty before the presentation of the bachelor thesis, at the latest by **01 June of the last year of study**.

Art.7. Rules for the presentation/submission of the bachelor thesis

(1) **Time and location of presentation:** graduates will be notified of the date, time, and location at which they will be able to present their thesis to the committee. Failure of the graduate to appear at the date, time, and location set may result in the graduate being eliminated from the licensing

examination. In emergency situations, alerts, situations in which the teaching activity is carried out online or other special situations established by the decisions of the VBUMPhT Board of Directors, the defense of the bachelor's thesis may also be carried out *online*, according to a procedure approved by the Board of Directors and endorsed by the University Senate.

(2) **The actual presentation.** The presentation of the bachelor's thesis is made by public oral presentation, for a maximum of 10 minutes, based on material created by the graduate which must include the most important aspects of the thesis. At the end of the presentation, the members of the committee may ask the graduate questions concerning: the subject of the thesis and/or the methodology and resources used, and the literature on the subject or related to it. It is recommended to present the thesis in **PowerPoint (PPT)** format with the following indicative structure: title of the thesis, the purpose of the thesis (optional, working hypotheses), the structure of the thesis - chapters, specific elements of the thesis, focus on the practical/applicative part, what he/she has followed, what methods he/she has used and what conclusions he/she has reached.

The use of 2 or 3 relevant tables or statistics on the phenomenon being investigated from the results of the Special Part is indicated.

Recommendations for the PPT presentation:

- The presentation should contain between 8 and 16 slides;
- a mandatory title slide containing the title of the paper, the name of the graduate and the name of the coordinating teacher(s), the discipline;
- 6-10 slides with text, tables, and figures (these will present the main aspects of the Special Part of the thesis that one wishes to communicate to the committee);
- 1-2 slides for conclusions.

Art.8. Evaluation of the Bachelor thesis

- (1) The evaluation of the undergraduate work shall be carried out by a committee consisting of a chairman, three members and a secretary; the secretary is not entitled to mark.
- (2) The members of the Evaluation Commission with the right to mark can only be teaching staff, and members of the VBUMPhT.
- (3) Each member of the committee, with the right to mark, awards a mark from 1 to 10 (whole numbers).
- (4) The final mark for the examination of the dissertation is the arithmetic mean of the individual marks of the members of the evaluation committee with the right to mark.
- (5) The results obtained in the examination of the bachelor's thesis may not be contested.
- (6) The faculties with a large number of students will set up several committees for the evaluation of the bachelor's thesis, the recommendation being, on average, 40-50 graduates/committee.
- (7) The composition and number of the committees shall be approved by the Faculty Council at least one month before the date of the undergraduate examination.

(8) Each committee shall be organised by related disciplines, including at least one specialist teacher from each discipline.

(9) The composition of the commissions and the distribution of students by commissions and rooms shall be published by posting at the Dean's Office of the Faculty and/or on the VBUMPhT website at least 3 days before the date of the examination.

Art.9. Final provisions

(1) The present Methodology for the preparation and examination of the Bachelor's degree complements the Regulation on the organisation and conduct of the Bachelor's degree examination.

(2) Each faculty is free to develop its own regulations and instruments that contribute to the smooth conduct of the licensing examination, provided that they do not violate the provisions of this methodology.

(3) The Rector of VBUMPhT may cancel, with the approval of the University Senate, a bachelor's degree examination when it is proved that fraudulent means were used in its realization.

(4) The methodology for the preparation of the bachelor thesis may be modified at the request of the Faculty Councils, by resolution of the Board of Directors and with the approval of the University Senate.

(5) The present Methodology for the preparation and examination of the Bachelor's degree was approved and republished in the Senate meeting of 30 March 2022, supplemented and amended on 22 February 2023, the date from which it comes into force.
