## THE CALENDAR OF THE LICENSING EXAMINATION ORGANISED WITHIN THE "VICTOR BABES" UNIVERSITY OF MEDICINE AND PHARMACY OF TIMISOARA, FOR THE 2022-2023 ACADEMIC YEAR GRADUATION

Art. 1. The licensing examination will be organised by VBUMPhT in the following sessions, under the same conditions, as follows:

## a) Ist Session:

- in September 2023, for all the study programmes within the Faculties of Medicine, Dental Medicne and Pharmacy
- b) II<sup>nd</sup> Session, keeping the same licensing committees established for the first session of the licensing examination:
- in February 2024, for all the study programmes in the Faculties of Medicine, Dental Medicne and Pharmacy

## **Art. 2. The timetable for the licensing examination** is as follows:

- a) in September 2023 all the study programmes within the Faculties of Medicine, Dental Medicine and Pharmacy:
  - 12 September 2023, 10.00 hours the written examination (for all the study programmes in the Faculties of Medicine, Dentistry and Pharmacy);
  - 13 September 2023 the **practical test** (for the study programmes in the Faculties of Dental Medicine and Pharmacy);
  - 14-15 September 2023 the presentation of the licence thesis (for all the study programmes within the Faculties of Medicine, Dental Medicine and Pharmacy).
- b) in February 2024, all the study programmes in the Faculties of Medicine, Dental Medicine and Pharmacy:
  - 06 February 2024, 10.00 a.m. the written test (for all the study programmes within the Faculties of Medicine, Dental Medicine and Pharmacy);
  - 07 February 2024 the **practical test** (for the study programmes within the Faculties of Dental Medicine and Pharmacy);
  - 08-09 February 2024 the presentation of the licence thesis (for all the study programmes within the Faculties of Medicine, Dental Medicine and Pharmacy).
- Art. 3. The registration of the candidates for the graduation examination will be made individually, at the deans' offices of the faculties, by submitting the licence theses together with the abstract and the report of the thesis, the certificates of linguistic proficiency and the affidavit on the originality of the content of the thesis, signed by the graduate and the scientific coordinator, as follows:
  - by 15 July 2023, for the September session of the licence examination;
  - by 16 December 2023, for the February session of the licence examination.
- Art. 4. The submission of undergraduate papers to be checked with the anti-plagiarism software used by the University will be done by 10 July 2023 at the latest, for all undergraduate programmes.
- Art. 5. The technical briefing attended by the members of the undergraduate committees, together with the heads of the halls and the supervisors, will be organized by the Central Licence Committee at least one week before the first session of the written examination, in the Aula Magna of the University (or online, link sent by e-mail, in justified cases).
