Art. 1.

This Regulation has been drawn up based on the following legal provisions:

- National Education Law no. 1/2011, as amended and supplemented,
- GEO No 194/2002, republished;
- O.G. No 22/2009, approved by Law No 1/2010;

Charter the "Victor Babeș" University of Medicine and Pharmacy of Timișoara, adopted by the Resolution of the University Senate, no.75/12188/16.09.2020.

Art. 2.

A person may receive funding from the budget for only one bachelor's programme, only one master's programme, and for only one doctoral programme.

Art. 3.

(1) The amount of the tuition fee, for all the university study cycles, will be approved annually by the University Senate, through its own admission regulations, and the students, respectively master/doctoral students will be notified before the beginning of the new academic year, within the term provided by law.

(2) The amount of tuition fees will not change during an academic year.

(3) The amount of tuition fees will not be changed until the end of the university study programme, unless there are situations that exceed the duration of tuition provided by law.

Art. 4.

(1) The students enrolled in all the cycles of university studies at the "Victor Babeș" University of Medicine and Pharmacy of Timișoara, as well as the doctors enrolled in the specialization, have the obligation to pay the tuition fees, under the conditions established by this Regulation, by the study contract, as well as by the internal regulations of the University.

(2) The study contract regulates the student's financial obligations, approved by the University Senate, and stipulated in these Regulations and other regulations and methodologies. The template of the Study Contract, respectively of the Additional Act to the Study Contract, will be approved annually by the University Senate, prior to the beginning of the academic year, and will be approved for the legality, respectively for preventive financial control, by the Legal Department of the University and the Financial-Accounting Department.

(3) In the event of exceeding the duration of tuition prescribed by law, as a result of repetition, resumption of studies in case of interruption, or re-enrolment after expulsion or withdrawal, a new university study contract will be concluded, under the conditions established by the university at the time of conclusion of the contract, the amount of the tuition fee being set at the level of the tuition fee for the year of study in which the student is enrolled.

(4) Students enrolled in fee-paying places, following the approval of academic mobility or recognition of periods of study undertaken in other higher education institutions abroad, will pay the tuition fee provided for the year of study in which they are enrolled.

(5) Students who occupy a budgeted place because of reclassification are entitled, on request (see Annex 5B), to a refund of the tuition fee paid in advance for the academic year in question. Students who take up a fee-paying place because of reclassification will pay the fee for the year of study in which they enroll.

(6) The costs related to exceeding the duration of the free tuition, provided for by law, in case of extension of the duration of the doctoral degree programme by 1-2 years, respectively extension of the duration of the doctoral degree programme by granting a grace period, will be borne by the doctoral student, the amount of the tuition fee being set at the level of the tuition fee related to the first year of study of the current academic year in which he/she enrolls for the extension of studies.

(7) Doctoral students in the period of extension of their doctoral studies, i.e. grace, who submit their doctoral thesis to the Doctoral School Secretariat by the starting date of the session, according to the structure of the academic year, may benefit from the refund of the tuition fees paid for the semester in which the doctoral thesis was submitted, based on a written request approved by the CSUD Board.

Art. 5.

(1) The amount of tuition fees is established by the University Senate, according to these Regulations, Annex no. 1.

(2) The amount of fees charged for registration, re-registration, repetition of examinations, and other forms of verification, which go beyond the provisions of the curriculum and for activities not included in the curriculum, as well as other fees, is established by the University Senate, according to the present Regulation, Annex no. 2.

(3) Debits for tuition fees in a foreign currency will be recorded in the accounts at the Euro/RON reference rate on 1 August of the current year, valid until 31 July of the following year.

(4) Romanian students benefit, upon request, from the following special fee reductions with the opinion of the Legal Office, the Dean of the Faculty, and with the approval of the Rector of the University, as follows:

- 75% discount on all fees set out in Annexes 1 and 2 of this Regulation for students - **up to the age of 26 - orphaned by both parents;**
- a 50% reduction on all fees set out in Annexes 1 and 2 to these Regulations for students - **up to the age of 26 - who have lost one parent;**

(5) Applications for fee reduction (Annexes 3 and 4) will be submitted to the secretariats of the faculties prior to enrolment or, if applicable, during the academic year, after the death of the parent, only once during the period of enrolment in a university study programme. Applications must be accompanied by the following documents:

- A copy of the ID card showing residence in Romania;
- Copy of birth certificate;
- Copy of parent's/parents' death certificate.

Art. 6.

(1) For **all** university studies, **in the first year of study** (upon enrollment) the tuition fee is paid in full.

(2) Starting from the second year of study, for **all** cycles of university studies, students may pay the tuition fee **in full or in two equal installments, within 30 days** of the beginning of the academic year, respectively of the beginning of the second semester (for students who pay the tuition fee in two equal installments).

Art. 7.

(1) After the expiry of the 30-day period provided for in this Regulation for the payment of tuition fees, based on the accounting records, for students enrolled in years II-VI of study, for master students enrolled in year II of study and doctoral students enrolled in years II-IV of study, respectively for doctoral students in the extension of doctoral studies/grace period VBUMPhT applies **penalties of 0.1% for each calendar day of delay in relation to the amount due, for a period of 60 calendar days from the due date.**

(2) After the expiry of **90 days**, VBUMPhT has the right to expel students, master's students, and doctoral students who cannot provide proof of payment of the tuition fee within the time limit set out in this Regulation.

(3) Re-enrolment will be done in the following academic year, with the payment of the tuition fees for the year of study in which they are re-enrolled and the payment of a re-enrolment fee.

(4) In case of expulsion of students, master students, and doctoral students, the University is entitled to recover the debts accrued by the student up to the date of expulsion and/or material damages.



Art. 8.

(1) Payment of tuition fees set in RON may be made:

- a. at the University cashier's office;
- b. by bank transfer, to the University's account, opened at TREZORERIA TIMIȘOARA: RO21TREZ62120F330500XXXX, fiscal code: 4269215, with the following mention: "tuition fee - name and surname of the student, CNP, year of study, study programme";
- c. online, by credit card.

(2) Payment of tuition fees for the first year of study will be made under the conditions laid down in the admission regulations.

(3) The payment of tuition fees established in foreign currency, respectively for students enrolled in study programmes taught in foreign languages, as well as for students from third countries, who are not members of the European Union, the European Economic Area, or the Swiss Confederation, will be made by bank transfer to the account of the University: RO53BTRL03604202A6896600, opened at Banca TRANSILVANIA SA, Baroc Agency, Str. Palanca nr. 2, Piața Unirii, SWIFT/BIC code: BTRLRO22TMA, with the following mandatory mentions: "tuition fee - student's name and surname, year of study, faculty/programme of study", or online by credit card.

Art. 9.

(1) The tuition fee for the complementary year is payable in proportion to the number of outstanding credits, but not more than the equivalent of 60 credits, referred to as the tuition fee for the year of study in which the student is enrolled. Outstanding credits mean all outstanding credits within the cycle, which have not been approved at the time of enrolment in the complementary year.

(2) On resumption of studies, the tuition fee for students enrolling in the complementary year and those who have interrupted their studies will be paid at the level of the tuition fee for the year of study in which the student enrolls, in accordance with the new contract.

(3) Foreign students, non-EU citizens, studying on their own account, will not be subject to the provisions of para. (1), the tuition fee for the complementary year being at the level of the tuition fee for the year of study in which the student is enrolled, in the amount established by the University Senate in these Regulations.

(4) In case foreign students, non-EU citizens, with scholarships from the Romanian State, repeat a year of study, they must pay the tuition fee in foreign currency, related to the year of study they repeat.

(5) If Romanian students from everywhere, who are Romanian State scholarship holders, repeat a year of study, they must pay the tuition fee in RON, related to the year of study they repeat, under the same conditions as Romanian citizens.

Art. 10.

(1) Repeating students who have not obtained the number of credits required to pass the year of study for medical reasons will follow the complementary year without financial obligations if they have paid the full tuition fee in the year of interruption of studies for medical reasons.

(2) In this case, students will submit medical documents, which will be examined and approved by the University Medical Commission, endorsed by the Dean of the faculty in which the student is enrolled, and approved by the University Administrative Board, in accordance with the provisions of the Regulation on the organization and conduct of students' professional activity in undergraduate studies.

Art. 11.

For taking examinations of subjects with outstanding transferable credits/deferment (where applicable), students will pay the fee established by the University Senate by these Regulations.

Art. 12.

- (1) Students who, in the complementary year, apply for credits in advance will pay the tuition fee of the complementary year in full.
- (2) Obtaining credits in advance for a study year will not be followed by a reduction of the tuition fee for that year.

Art. 13.

- (1) A student who applies for withdrawal/withdrawal of studies is obliged to pay the full tuition fee for the current year.
- (2) In case of withdrawal, interruption of studies, or expulsion, the tuition fee paid for the current year will not be refunded.
- (3) In the case of students enrolled in the first year who have signed the study contract, but who withdraw/interrupt their university studies, before the issuance of the enrolment decision/ order of admission to studies (for students who have taken the type III - International entrance examination), the tuition fee is refunded, upon written request of the student, with the approval of the Rector.
- (4) For the refund of the tuition fee, the student will submit to the University Registrar's Office an application in accordance with Annex 5A or 5B of these Regulations. After the approval of the application by the Rector of the University, the Finance and Accounting Department will make the tuition fee refund within 30 days from the date of registration of the application.
- (5) Students enrolled in a higher year who request withdrawal/termination of studies before the end of the enrollment period are not required to pay the tuition fee for the current year.
- (6) In the case of expulsion, except in cases of expulsion for non-enrollment, the tuition fee paid for the current year is not refunded.
- (7) The tuition fees paid in the case of withdrawal from studies, expulsion, or mobility to other institutions organizing doctoral studies will not be refunded.

Art. 14.

- (1) The "Victor Babeș" University of Medicine and Pharmacy of Timișoara collects from the candidates, in accordance with the legal provisions in force, registration fees for the organization and conduct of the admission, in the amounts approved by the University Senate, through its own admission regulations.
- (2) Exemption from or reduction of these admission fees will be approved by the University Senate, through its own admission regulations.

Art. 15.

For admission to the "Victor Babeș" University of Medicine and Pharmacy of Timișoara, for each cycle and programme of university studies, citizens of the Member States of the European Union, of the states belonging to the European Economic Area and of the Swiss Confederation will be subject to the same conditions as those provided by law for Romanian citizens, including tuition fees.

Art. 16.

Graduates may sit for the final examination, in sessions after those organized for the class of which they are a part, if they bear the related expenses, in the amount established by the University Senate through this Regulation.

Art. 17.



The "Victor Babeș" University of Medicine and Pharmacy of Timișoara charges accommodation fees, in accordance with the legal provisions in force, in the amounts approved by the University Senate, through its own accommodation regulations.

Art. 18.

The "Victor Babeș" University of Medicine and Pharmacy of Timișoara charges candidates' registration/participation fees for the competition (competition for vacant teaching positions, etc.), in accordance with the legal provisions in force, in the amounts approved by the University Senate, through its own competition regulations.

Art. 19.

This Regulation was republished and approved at the meeting of the University Senate on 05 April 2023, on which date it comes into force.
