Art. 1.

This Regulation has been developed on the basis of the following legal provisions:

- Law on Higher Education No 199/2023, with subsequent amendments and additions
- GEO no 194/2002 on the regime of foreigners in Romania, republished;
- Government Ordinance no. 22/2009 regarding the establishment of the minimum amount of tuition fees, in foreign currency, for citizens studying on their own in Romania, from countries that are not members of the European Union, as well as from countries that are not part of the European Economic Area and the Swiss Confederation, approved by Law no. 1/2010;
- Charter of the "Victor Babes" University of Medicine and Pharmacy "Victor Babes" of Timisoara, adopted by the University Senate Decision, no. 245/31770/22.11.2023.

Art. 2.

A person can only receive budget funding for one bachelor's programme, one master's programme and one doctoral programme.

Art. 3.

(1) For all university study cycles, the amount of the tuition fee is approved annually by the Senate of the University, upon the proposal of the Council of Administration, and is made known to the candidates on the date of publication of the educational offer, at least 6 months before the admission examination, according to the framework methodology on the organisation of admission to bachelor, master and doctoral university study cycles.

(2) Tuition fees do not change during the course of an academic year.

(3) The amount of the tuition fee remains unchanged until the end of the university study programme, unless the duration of tuition provided for by law is exceeded.

(4) The fees charged by the University are approved by the University Senate and published on the University website at least 3 months before the beginning of each academic year.

Art. 4.

(1) Students enrolled in all cycles of undergraduate studies at the "Victor Babes" University of Medicine and Pharmacy "Victor Babes" of Timisoara, as well as doctors enrolled in specialisation, are obliged to pay tuition fees, under the conditions established by these Regulations, the study contract, as well as the internal regulations of the University.

(2) The study contract regulates the student's financial obligations, approved by the University Senate and stipulated in this Regulation, as well as in other regulations and methodologies. The model of the Study Contract, respectively of the Additional Act to the Study Contract, is approved annually by the University Senate, prior to the beginning of the academic year, and is checked for legality, respectively for preventive financial control, by the Legal Department of the University and the Financial and Accounting Department.

(3) In the event of exceeding the duration of tuition provided for by law, as a result of repetition, resumption of studies in case of interruption, or re-enrolment after expulsion or withdrawal, a new university study contract is concluded, under the conditions established by the university at the time of the conclusion of the contract, the amount of tuition fee being set at the level of the tuition fee for the year of study in which the student enrolls.

(4) Students enrolled on fee-paying places, following the approval of academic mobility or the recognition of periods of study undertaken in other higher education institutions abroad, will pay the tuition fee for the year of study in which they are enrolled.

(5) Students who occupy a budgeted place as a result of reclassification are entitled, on request (see Annex 5B), to a refund of the tuition fee paid in advance for the academic year in question. Students occupying a fee-paying place as a result of reclassification will pay the fee for the year of study in which they enrol.

(6) The costs related to exceeding the duration of the free tuition, provided for by law, in the case of extending the duration of the doctoral programme by 1-2 years, shall be borne by the doctoral student, the amount of the tuition fee being set at the level of the tuition fee for the first year of study in the current academic year in which he/she enrolls for the extension of studies

(7) Doctoral students in the period of extension of their doctoral studies, who submit their doctoral thesis to the Doctoral School Secretariat by the starting date of the session, according to the structure of the academic year, may benefit from the refund of tuition fees paid for the semester in which the doctoral thesis was submitted, based on a written request approved by the CSUD Council.

Art. 5.

(1) The amount of tuition fees is set by the University Senate, upon the proposal of the Council of Administration, according to the present Regulation, Annex no.1.

(2) The amount of the fees charged for enrolment, re-enrolment, repeat examinations and other forms of verification, which exceed the provisions of the curriculum and for activities not included in the curriculum, as well as other fees, is set by the University Senate, upon proposal of the Council of Administration, according to the present Regulation, Annex no. 2.

(3) Amounts due in respect of tuition fees in foreign currency shall be entered in the accounts at the euro/leu reference rate on 1 August of the current year and shall be valid until 31 July of the following year.

(4) Romanian students benefit, upon request, of the following special fee reductions with the opinion of the Legal Office, the Dean of the faculty and with the approval of the Rector of the university, as follows:

- 75% reduction on all fees set out in Annexes 1 and 2 of this Regulation for students orphaned **by both parents until the age of 26;**
- a 50 per cent reduction on all the fees set out in Annexes 1 and 2 of this Regulation for students who have lost **one parent until the age of 26;**

(5) Applications for fee reduction (Annexes no. 3 and 4) must be submitted to the secretariats of the faculties, prior to enrolment or, where appropriate, during the academic year, after the death of the parent, once during the period of enrolment in a university study programme. Applications must be accompanied by the following documents:

- Copy of your identity card, showing your residence in Romania;
- Copy of birth certificate;
- Copy of death certificate parents/parent.

(6) The full professors of the university and auxiliary teaching staff who follow the master and doctorate programmes of the "Victor Babes" University Medicine and Pharmacy "Victor Babes" of Timisoara, benefit from a 50% reduction of the tuition fees.

(1) For **all** undergraduate programmes, tuition fees for the **first year of study** (upon enrolment) are payable **in full, within** the deadlines set out in the admission regulations.

(2) Starting with the second year of studies, for **all** cycles of university studies, students may pay the tuition fee **in full or in two equal instalments, within 30 days of** the start of the academic year, respectively of the start of the second semester (for students paying the tuition fee in two equal instalments).

Art. 7.

(1) After the expiry of the 30-day deadline stipulated by this Regulation for the payment of tuition fees, based on the accounting records, for students enrolled in years II-VI of studies, for master students enrolled in the second year of studies and doctoral students enrolled in years II-IV of studies, respectively for doctoral students in the process of extending their doctoral studies, UMFVBT shall apply **penalties for a period of 30 calendar days from the due date, calculated as follows:**

- For study programmes (admission type I, cycle III - doctorate) - 20 lei/week for those who pay the full tuition fee and 10 lei/week for those who pay in instalments;
- For study programmes (admission type II) - 10 lei/week for those who pay the full tuition fee and 5 lei/week for those who pay in instalments;
- For study programmes (admission type III) - €20/week for those who pay the full tuition fee and €10/week for those who pay in instalments;
- For master's degree programmes - 5 lei/week for those who pay the full tuition fee and 2.5 lei/week for those who pay in instalments;

(2) After the expiry of **60 days**, UMFVBT has the right to expel students, master students and doctoral students who cannot provide proof of payment of tuition fees within the deadline set out in this Regulation.

(3) Re-enrolment is for the following academic year, subject to payment of the tuition fees for the year of study in which you are re-enrolling and a re-enrolment fee.

(4) In the case of expulsion of students, master students and doctoral students, the University is entitled to recover the debts accrued by the student up to the date of expulsion and/or material damages

Art. 8.

(1) Payment of tuition fees set in lei can be made:

- at the university cash desk;
- by bank transfer to the University's account, opened at TREZORERIA TIMIȘOARA: RO21TREZ62120F330500XXXX, tax code: 4269215, with the following mentions: *"tuition fee - student's name and surname, CNP, year of study, study programme"*;
- online, by card.

(2) Tuition fees for the first year of studies are paid in accordance with the admission regulations.

(3) The payment of tuition fees established in foreign currency, respectively for students enrolled in study programmes with foreign language teaching, as well as for students from third countries that are not members of the European Union, the European Economic Area or the Swiss Confederation, shall be made by bank transfer to the University's account: RO53BTRL03604202A6896600, opened at Banca TRANSILVANIA SA, Baroc Agency, Str. Palanca nr. 2, Piața Unirii, SWIFT/BIC Code: BTRLRO22TMA, with the following mandatory mentions: *"tuition fee - student's name and surname, year of study, Faculty/curriculum"*, or on-line by credit card.

(1) The tuition fee for the complementary year is payable in proportion to the number of credits outstanding, but no more than the equivalent of 60 credits, based on the tuition fee for the year of study in which the student enrolls. Outstanding credits means all outstanding credits within the cycle which have not been passed at the date of enrolment in the complementary year.

(2) Upon resumption of studies, the tuition fee for students enrolling in a complementary year and those who have interrupted their studies is payable at the level of the tuition fee for the year of study in which the student enrolled, in accordance with the new contract/additional act.

(3) Foreign students, non-EU citizens, who study on their own currency, are not subject to the provisions of paragraph. (1), the tuition fee for the complementary year being at the same level as the tuition fee for the year of study in which the student is enrolled, in the amount established by the University Senate in this Regulation.

(4) In case foreign students, non-EU citizens, Romanian state scholarship holders, repeat a year of study, they must pay the tuition fee in foreign currency for the year of study they are repeating.

(5) If Romanian students from abroad, who are Romanian state scholarship holders, repeat a year of study, they must pay the tuition fee in lei for the year of study they are repeating, under the same conditions as Romanian citizens.

Art. 10.

(1) Repeat students who have not obtained the number of credits required to pass the year of study for medical reasons will follow the complementary year without financial obligations, if they have paid the full tuition fee in the year of interruption of studies for medical reasons.

(2) In this situation, the students will submit medical documents proving their medical evidence, which will be analysed and endorsed by the Medical Commission of the university, endorsed by the Dean of the faculty where the student is enrolled and approved by the Administrative Board of the university, according to the provisions of the Regulation on the organisation and conduct of the professional activity of students in the framework of undergraduate studies.

Art. 11.

To sit for the examinations of subjects with outstanding transferable credits/deferred credits (where applicable), students pay the fee established by the University Senate through the present Regulation.

Art. 12.

(1) Students who, in the complementary year, apply for credits in advance will pay the complementary year's tuition fee in full.

(2) The granting of credits in advance for a year of study is not followed by a reduction in the tuition fee for that year.

Art. 13.

(1) The student or doctoral student, respectively, who applies to withdraw/withdraw from/withdraw from university studies is required to pay the full tuition fee for the current year.

(2) In case of withdrawal, interruption of university studies or expulsion, except, respectively, in the case of mobilities to other institutions organizing doctoral university studies, the tuition fee paid for the current year is not refunded.

(3) In the case of students enrolled in the first year who have signed the study contract, but who withdraw/interrupt their studies, before the issuing of the enrolment decision/the order of admission to studies (for students who have taken the admission III - International), the tuition fee is refunded, upon written request of the student, with the approval of the Rector.

(4) For the tuition fee refund, the student will submit to the University Registrar's Office an application according to Annex 5A or 5B of this Regulation. After the application has been approved by the Rector of the University, the Finance and Accounting Department will refund the tuition fee within 30 days from the date of registration of the application.

(5) Students enrolled in the senior year, who request withdrawal/interruption of studies before the end of the 30 calendar days from the start of the academic year (enrollment), are not required to pay the tuition fee for the current year.

Art. 14.

(1) The "Victor Babes" University of Medicine and Pharmacy "Victor Babes" of Timisoara charges candidates, in accordance with the legal provisions in force, application fees for the organisation and conduct of admission, in the amounts approved by the University Senate, by its own admission regulations.

(2) The University Senate, through its own admission regulations, approves the waiver or reduction of these fees.

Art. 15.

For admission to the "Victor Babes" University of Medicine and Pharmacy of Timișoara, for each cycle and programme of university studies, citizens of the Member States of the European Union, of the States belonging to the European Economic Area and of the Swiss Confederation, as well as British citizens and members of their families, as beneficiaries of the Agreement on the Withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community 2019/C 384 I/01, are subject to the same conditions provided by law for Romanian citizens, including tuition fees

Art. 16.

The presentation of graduates to the final exam, in sessions subsequent to those organised for the graduating class to which they belong, as well as the repetition of the final exam, may be done with the payment of the related expenses, in the amount established by the University Senate by the present Regulation.

Art. 17.

The "Victor Babes" University of Medicine and Pharmacy of Timisoara charges accommodation fees, in accordance with the legal provisions in force, in the amounts approved by the University Senate, through its own accommodation regulations.

Art. 18.

The "Victor Babes" University of Medicine and Pharmacy "Victor Babes" of Timisoara charges the candidates' fees for enrolment/participation in the competition (competition for vacant teaching posts, etc.), in accordance with the legal provisions in force, in the amounts approved by the University Senate, by its own regulations for the organisation of the competition.
